# **Optimising Fodder Options in Mixed Farming Systems**

#### 1. Introduction

Wheatbelt NRM is seeking submissions from a suitably qualified and experienced consultant to undertake an economic analysis to demonstrate the possible production benefits of implementing a systems approach to summer ground cover.

We are seeking an economist or farm business modeller with a thorough understanding of mixed farming in the West Australian Wheatbelt, and extensive knowledge of agricultural economics and/or farm business modelling.

It is expected that the final product will be

- Eight economic analysis reports, one per farm.
- Overall analysis of findings

#### 2. Background Information

Wheatbelt Natural Resource Management Incorporated (Wheatbelt NRM) is an independent community-based organisation leading natural resource management (NRM) endeavours within the Avon River Basin. The organisation operates from its Northam office, Western Australia, and exists as the second largest of the seven NRM regional organisations in the State, with responsibility for the 12,000,000 hectares of the Avon River Basin.

The Optimising Fodder Options in Mixed Farming Systems project is being delivered as part of the Australian Government's National Landcare Program.

The primary outcome of this project will be to increase summer ground cover.

### Project activity will include:

# **Planning**

• Helping mixed farmers optimise fodder, forage and pasture options to fill summer feed gaps and increase ground cover.

#### **Events**

- There will be events, field days, demonstrations and practical workshops to bring the latest information and analysis on options suited to individual farm businesses.

  Demonstrations
- Eight Farm Demonstration Sites working with industry influencers will deliver a whole of farm approach to feed management. Summer crops, perennial pastures and shrubs will form the basis of on farm demonstrations that showcase a systems approach to summer feed options. These summer feed gap options will increase ground cover, stabilise soil and increase soil carbon. Field days and other extension activities will support peer to peer learning.
- Four summer ground cover plan sites will be used as examples to support a peer to peer
  extension process that will enable mixed farmers to benefit from seeing the planning process
  in action.

#### **Toolbox**

• A Toolbox will also be developed to support them to identify the best approach for their farm. (A separate consultancy will be developed for the farm planning and Toolbox.)

#### **Analysis**

 Economic analysis of the production benefits of summer grazing options will encourage further adoption.

# 3. Period of contract

The contract will commence Monday 26<sup>th</sup> August and conclude the 30<sup>th</sup> June 2023.

# 4. Objectives

The main task of the consultant will be to undertake economic analysis of the production benefits of summer grazing options to be demonstrated in 8 demonstration sites across the Wheatbelt.

Specific objectives include:

- Work with the project farm planner to identify which options are being used at each farm and assess the demonstration activities individually and as a whole farm operation economically
- Work directly with 8 farmers to analyse the economic benefits (or otherwise) of changes to their livestock enterprise as a result of the project Present findings in a final report, and as a part of normal project extension activities

# 5. Scope of works

This section provides a description of the scope of works of the Contract.

- Carry out an economic modelling exercise for 8 demonstration famers
- Identify impacts of key decisions made as part of the farm planning
- Model potential economic benefits (or not) of proposed actions
- Present at project workshops on modelling results
- Present a final report for each demonstration farm. Structure and audience for report to be determined with Wheatbelt NRM

This consultancy is ongoing as required through the life of the project. Workload will vary in accordance with the deliverables required.
